I urge you to reject the submission from Tony Fleming, TVT Integrity Commissioner Annual Report submitted at the April 7 COW meeting.

There are several blatant inaccuracies.

There were at least 3 formal complaints to the TVT Integrity Commissioner in 2025 of which I am aware. All complainants were charged fees.

The complaint regarding Deputy Reeve Dobbie was dismissed by the TVT Integrity Commissioner citing inaccurate representations and remedies that did not

occur. No public witnesses were interviewed. The source of the TVT Integrity Commissioner who provided "The substance" of the Dobbie statements was not cited. There is no evidence that the Dobbie apology was ever delivered. There is no record of the incident in the meeting minutes. There was no apology or clarification of the outburst to the victims of the abuse.

Complaints of false information in the IC report directed to Council and the IC were ignored.

Please compel the Integrity Commissioner to correct the error and reevaluate his decision prior to May 1 at which time all Integrity Commissioner inquiries must be suspended.

"John:

While several complaints to the Integrity Commissioner were filed, 2 were dismissed and one was investigated. The two that were dismissed without investigation had no fees for the IC. For the complaint that was investigated, the conclusion resulted in dismissal of that complaint also; however, time by the IC was spent on it.

There seems to be some confusion around application fees which are paid to the Township, and fees for investigation paid to the IC.

The IC has reported correctly that there was only one complaint that was investigated, and that one complaint had IC fees.

Reeve Rainers deceptive reply has no merit. He only choses to address the issue of fees. No response is given for the false claims in the TVT Intefrity Commissioner report.

Reeve Rainer implies that unless the TVT Integrity Commissioner charges TVT for a complaint, it did not exist. Filing fees (\$150 each) were collected from the complainants.

The complaint lodged against the inappropriate behaviour of Dobbie was dismissed in a two page decision in one communication.

The complaint lodged against Reeve Rainer for lying to the CBC amongst other infractions generated four contacts involving seven written pages of Integrity Commissioner communication sent to the complainant. In addition there were several email communications.

Apparently the TVT was not charged for this service. That has no bearing on the false statement that there was only one complaint.

All Councillors, with the exception of one are well aware of the multiple complaints in 2025 to the TVT Integrity Commissioner. They, except for one, were all aware of one complaint lodged against them and the Dobbie complaint.

Further, in the editorial section of the Integrity Report delves into the past performance of a TVT working group (PURWG) in the 2018-2022 term. Mr Fleming states the (PURWG) report was biased and incorrect based on incorrect legal assumptions. What Mr Fleming did not state was that **TVT CAO Amanda Mabo refused repeated requests from the the PURWG to fund legal consultations.**

The truth is the PURWG was doomed to failure from the onset in order to support TVT CAO Amanda Mabo's decision to refuse to comply with an order of Council.

TVT Council continues to support false Staff reports.
